Dundee Local Development Plan 2 - Proposed Plan: Period of Representation

The Dundee Local Development Plan 2 – Proposed Plan and supporting documents were approved by Elected Members on Monday 21st August 2017. They have now been published and are subject to consultation through a 6 week period of representation.

The Proposed Plan is the Council's settled view on the land use strategy, policy framework and proposals that should be contained within the next Dundee Local Development Plan. The content of the Proposed Plan has been prepared following the consultation on the Main Issues Report in 2016 and subsequent comments received throughout its preparation from Key Agencies, and stakeholders such as developers, landowners and agents as well as the local community through analysis of the Local Community Plans and the results of the Engage Dundee consultation.

The Proposed Plan and its Action Programme have been informed by the Environmental Report and a Habitats Regulations Appraisal.

A period of representation will run for 6 weeks and will start on Monday 28th August 2017 and finish on Monday 9th October 2017.

During this time we would invite representations on any unresolved matters arising from these documents that should be considered through the Examination of the Plan by an independent Reporter appointed by the Scottish Government.

We have also published three pieces of Draft Supplementary Guidance in support of the Local Development Plan and invite comments on these in parallel to the main consultation.

The Proposed Plan, Environmental Report, Habitats Regulations Appraisal, Supplementary Guidance and supporting documents are available to view online via www.dundeecity.gov.uk/localdevplan2 Hard copies of the Proposed Plan and Environmental Report are available to view at Dundee House and copies of the Proposed Plan are also available to view at local libraries.
