1. WELCOME AND APOLOGIES

ENGAGE DUNDEE & FAIRNESS COMMISSION FINDINGS

5. DEPARTMENT, AGENCY AND ORGANISATION UPDATES

Range of reports shared in advance. In addition:

Churches Group

David Easson reported that the Churches Group, Broughty Ferry Community Council and the Rotary are in discussion about exploring the possibility of a Community Fridge in the Ferry. Representatives from the West End Community Fridge have been involved in some of the discussions and are providing insight into the process and timescale of the initiative (thought to be about 3 years). David will continue to update.

Broughty Ferry Community Council (BFCC)

David Easson reported that the group have been meeting online. Key discussions included the Flood Defence Project, cycle paths, community fridge. Meetings are open to the public and publicised via Facebook and the website. BFCC were successful in receiving funding towards a pop-up Police Woman which is being used as a traffic calming measure in Broughty Ferry.
Suggestions on where to use this are welcome through BFCC.

Sandy Boyd – Environment Department

Update on improvements at Dawson Park relating to the fountain and planting of Cherry Blossoms.

Joyce Barclay – Health and Social Care Partnership

Joyce mentioned the impact of Covid and highlighted key points such as the increase in informal carers and an increase in fraud. Carole Jenkins will discuss with Community Safety Team/Police to find out what is being done to tackle fraud.

Audrey May – Children and Families Services

Grove was open during lockdown as a Hub for essential workers and vulnerable children. Overall, pupils are happy to return to school. There is a campaign by Jason Leitch highlighting that pupils are safe in school during the pandemic.

Schools await decisions regarding internal assessments.

The Christmas holidays will commence from 23rd December.

Graeme Hutton – Grove Academy

Since level 3 was announced, pupils in Grove have been asked to wear facemasks and additional safety measures such as staggering lunch times and staff having a presence in Brook Street during lunch have been put in place. There have been some complaints regarding pupils in Brook Street at lunch time. The school will continue to work with the community and monitor the situation as best as they can given the capacity of staff.

Councillor Phillip Scott

There will be a meeting to discuss traffic calming measures on Fairfield Road. Changes to the catchment area for Grove will include Craigie Barns.

Karen raised the traffic speed at Balgillo Road; David Easson highlighted that this had been identified as a hotspot for the pop-up police figure.

There was a suggestion to put zigzags outside Barnhill, replace a fence and install traffic lights at East Balgillo Road junction.

Councillor Philip Scott will get in touch regarding the speed report and update.

Baillie Scott tried to attend the meeting but experienced difficulties with Microsoft Teams.
